- 2) **Submission** : Quotation with proper superscription on the cover should be submitted in the office of the Director, ICAR-NAARM, Rajendranagar, Hyderabad – 500 030 on or before the due date.
- 3) **Payment** : No advance payment is permissible. Payment will be made on monthly basis only after satisfactory completion of fogging work thrice in a week.
- 4) **Security Deposit** : The successful bidder has to furnish an amount equivalent to Ten (10) per cent of the order value as Security Deposit which will be refunded/returned only after satisfactory completion of the contractual obligations including warranty. The Security Deposit should be in the form of either Demand Draft or Bank Guarantee on which no interest will be paid.
- 5) **Validity** : The rates quoted shall be valid for a minimum period of 90 days, from the date of receipt of quotations.
- 6) **Rates** : Rates should be quoted in the Schedule of Requirements enclosed to this invitation or on the bidder's letter head in the same format.
