**Proceedings of the 3<sup>rd</sup> meeting with Pensioners/Family Pensioners organized by Pension Authorization Unit, ICAR-NAARM, Hyderabad for Pensioners/Family Pensioners of ICAR institutes located at Hyderabad**

In pursuance of ICAR Letter No.FIN/10/09/2018-Pension, dated 4<sup>th</sup> September, 2018, the 3<sup>rd</sup> Meeting with Pensioners/Family Pensioners, to resolve their grievances related to pension, was organized on 28.01.2019 at 11.30 a.m. in the Conference Hall of ICAR-NAARM under the Chairmanship of Director, ICAR-NAARM, Hyderabad. The list of participants is annexed.

At the outset, Sri S.George, CF&AO & PAO of PAU at Hyderabad welcomed the Pensioners and other officers who attended the meeting. He informed the house that as decided in the 2<sup>nd</sup> meeting with pensioners, a meeting with Administrative and Finance Officers of all institutes located at Hyderabad was organized on 18.12.2018 at ICAR-NAARM under the Chairmanship of Director and common issues related to Pensioners was deliberated for their speedy disposal. He also informed the house that revised PPOs have been issued to 90% of the Pre-2016 Pensioners and the remaining 10% of the cases would be completed at the earliest. He requested all the institutes to send the proposals, if any pending with them, for issuing revised PPOs at the earliest.

Thereafter, action taken report on the previous meeting was taken up.

**I. Item No.2018/11/2: Monthly meeting with Pensioners at respective Institute level**

Director, ICAR-NAARM and Chairman advised all the institutes to organize regular meetings with their Pensioners, irrespective of non-receipt of grievances from Pensioners.

**(i) ICAR-CRIDA, Hyderabad**

CAO informed that the next meeting with Pensioners is scheduled on 29.1.19.

**(ii) ICAR-IIRR, Hyderabad**

FAO informed that they conducted the meeting with their Pensioners.

**(iii) ICAR-IIOR, Hyderabad**

JAO informed that meeting with Pensioners was conducted.

**(iv) ICAR-PDP, Hyderabad**

AFAO informed that since they did not receive any grievance from their pensioners, no meeting was held.

**(v) ICAR-NRCM, Hyderabad**

AFAO informed that they conducted the meeting.

**(vi) ICAR-ATARI, Hyderabad**

AFAO informed that they conducted the meeting.

**(viii) ICAR-IIMR, Hyderabad**

FAO informed that meeting with Pensioners was conducted.

**II. Item No.2018/11/2: Authorization of Retirement Benefits and Revision of Pension as per VII CPC**

No issues.

**III. Item No.2018/11/3: Issue of Health Cards to Pensioners**

Mr.Ashish Roy, JD(A) & Registrar, ICAR-NAARM and Chairman of the Committee for development of Health Cards informed the house that revised application format has been devised and circulated to all institutes. Communication to pensioners for filling up and submission to the concerned institute from where they retired may be carried out, so that the concerned Head of Office would authenticate the details and forward the same to the Senior Admn. Officer, ICAR-

NAARM for issuing Health Cards. During the meeting copies of application format were distributed to the pensioners present.

#### **IV. Item No.2018/11/4: Credit Facility for In-patient treatment**

Issue of credit letter for providing cash-less in-patient medical treatment at various CGHS recognized hospitals was discussed at length. In order to adopt a uniform procedure and practice among all ICAR institutes located at Hyderabad, Chairman constituted a committee with the following composition:

Chairman clarified that Pensioners will be treated on par with regular employees for the purpose of extension of medical facility. Chairman also informed the house that ICAR-NAARM is bringing all the institutes on the same platform for facilitating cashless medical treatment.

Pensioners from SSS category, who attended the meeting, requested to extend credit facility for both Out Patient and In-patient medical treatment in view of their fragile financial position.

**V. The following grievances/ issues received by PAO were discussed and decided as under:**

1. Fixation of pay in respect of Mrs.Girija Kumari, Ex-AFAO, PDP, Hyderabad : It was discussed and suggested that ICAR-PDP has to organize Pensioners meeting and resolve the grievance at their end.
2. Revision of pension in respect of Dr.SVS Sastry, Ex-Project Co-ordinator : It is learnt that ICAR had not transferred the PPO along with relevant file of Dr.SVS Sastry, Ex-Project Co-ordinator to ICAR-CRIDA/NAARM. Since the original pension was authorized by ICAR, the Revised Pension order is to be issued by ICAR. Chairman suggested that FAO, IIRR has to follow up with ICAR for issuing RPPO. A copy of the letter received by ICAR-NAARM will be forwarded to IIRR, Hyderabad for necessary action.
3. Delay in authorization of Retirement Benefits pertaining to CTRI, Rajahmundry: By oversight, ICAR sent the letter to NAARM and the same would be forwarded to CTRI, Rajahmundry for taking necessary action.
4. Discrepancy in pension revision in respect of Dr.N.P.Sharma, IIRR, Hyderabad: PAO clarified that it would be rectified based on the concordance table formulated by ICAR for Scientific Category Pensioners. In view of the concordance table formulated by ICAR, all institutes are required to review the pension cases prior to 2006, at the earliest.

During the discussion/interaction, the following action points emerged:

**VI. Item No.2018/11/6: Issues relating to State Bank of India**

Sri R.Ramakrishna, Chief Manager, SBI, PJRSAU branch while addressing the gathering asked about the problems, if any, faced by pensioners from bank. Some of the pensioners voiced that they did not get the arrears of DA and arrears on account of revision of pension based on 7<sup>th</sup> CPC recommendations. He noted the issues raised by the pensioners and assured to look into it for early payment.

The Dy.Manager, SBI, CPPC, Koti advised the pensioners that if any investments are made for availing tax exemption, the details of the investments need to be submitted to the concerned branch for updation.


Dr.MVR Prasad, Director(Retd) IIOR expressed happiness to attend the Pensioners meeting for the first time.

Some of the pensioners informed that they did not get their revised PPOs due to change of their residential address, subsequent to their retirement. CF&AO informed that in such cases, new address has to be intimated to the PAU for updating and a copy of the revised PPO would be sent to the new address. All the Pensioners were also requested to furnish their email id to the bank, so that they can get alerts from bank whenever any payment is made, otherwise, they can directly approach the bank for getting their pension slips.

Some of the pensioners voiced that Service Books of some of the pensioners are missing and not traceable in certain institutes. In this context, they suggested that copy of service books of all Pensioners may be deposited with PAU, NAARM and a copy of the same may be provided to the concerned pensioner.

Chairman informed the house that the next meeting with Administrative and Finance Officers of all ICAR Institutes located in Hyderabad will be conducted in February, 2019 and in view of the of the financial year 2018-19 ending, the next and 4<sup>th</sup> meeting with Pensioners will be conducted during April, 2019.

The meeting came to an end by vote of thanks by Shri Ashish Roy, JD(A) & Registrar to the Chair and all the participants.
