<u>Proceedings of the 6th meeting with Pensioners/Family Pensioners (Pension Adalat) organized by Pension Authorization Unit, ICAR-NAARM, Hyderabad for Pensioners/Family Pensioners of ICAR institutes located at Hyderabad</u>

In pursuance of ICAR Letter No.FIN/10/09/2018-Pension, dated 26th July, 2019, the 6th Meeting with Pensioners/Family Pensioners, to resolve their grievances related to pension, was organized on 23.08.2019 at 3.00 p.m. in the Conference Hall under the Chairmanship of Director In charge, ICAR-NAARM, Hyderabad. The list of participants is annexed.

At the outset, Dr.R.V.S.Rao, Head HRM Division and CF&AO Incharge welcomed all Pensioners and other officers who attended the meeting. He also welcomed Sri S.George who contributed a lot as PAO till his superannuation on 31.07.2019 and requested him to clarify and give his valuable inputs to the house. He informed the house about the purpose and objective of conducting Pension Adalats and mentioned that the first Adalat was conducted on 18.09.2019 and this is the 6th Meeting in this series for resolving the issues of Pensioners. He also informed the house that Sri Z.H.Khilji who is posted as CF&AO and PAO would be joining the Academy shortly.

Chairman informed the house that this is the platform for raising issues of pensioners, which are not resolved by the concerned institutes during the pensioners meetings conducted by them. He said that all Administrative and Finance Officers of all ICAR institutes located at Hyderabad have to sensitize their staff in dealing with issues related to Pensioners. He also requested all the pensioners to attend the institute level meetings and submit their grievances to their respective institutes for resolving the issues early and promptly.

Chairman in his address informed the house about the following welfare measures being taken up by ICAR-NAARM:

- A Dental Health Camp at Health Centre at ICAR-NAARM and a Talk on Oral Health have been arranged today i.e.23.08.2019 for the benefit of all Pensioners who are attending the meeting and urged them to utilize the facility.
- 2. 58 numbers of Health Cards have been ready for distribution today.

Thereafter, action taken report on the items of the last meeting was reviewed.

Item No.2018/11/1: Holding of Monthly meeting with Pensioners at respective Institute level

Chairman reiterated Officers of all the Institutes to hold institute level pensioners meeting regularly for resolving the issues of pensioners in letter and spirit. Also they may intimate the notice of Pensioners Meeting being conducted by PAU i.e. ICAR-NAARM from time to time, to all their pensioners without fail.

Item No.2018/11/3: Issue of Health Cards to Pensioners

Chairman informed the house that so far 270 applications for arranging Health Identity Cards have been submitted by various institutes to ICAR-NAARM and Health Identity Cards have been issued to the Pensioners whose applications have been received with full information. Already 200 Cards have been issued and 58 Cards are ready for distribution today. Health Identity Card for Dr.E.A.Siddiq, Former DDG(Crop Science) ICAR, New Delhi has also been issued. The incomplete applications are being returned to the concerned institutes for doing the needful. He informed the house that some of the pensioners are still to submit their application through their Office from which they retired. He advised all officers of the ICAR Institutes to verify and forward the applications with complete information to ICAR-NAARM at the earliest, so as to facilitate issuing the remaining Health Cards.
