Annexure-II**Terms and Conditions for acceptance of Tenders, supply of Electrical Consumables on Annual Rate Contract basis of which the contract will be awarded are given below:**

- 1) **The Bidder(s) may note that ONLINE BIDS will ONLY be accepted. All the requisite supporting documents as mentioned in the bid document should and must be uploaded On-line <http://eprocure.gov.in/eprocure/app>. The Bids sent through FAX, E-mail, by hand and/or by post shall not be accepted/ processed, in any case.**
- 2) **The Reputed and Reliable registered Firms/Agencies/Manufacturers/Distributors etc. having valid Registration/Dealership & /PAN/GST/CST/IT/Service Clearance Certificate (the photo copies of the certificates/documents as the case may be, have to be mandatorily be uploaded as proof) in the E-tender.**
- 3) **The bidders may submit duly filled and completed bidding document ONLINE as per instruction contained in the bidding documents. Incomplete bid shall be rejected. The conditions of tender shall be governed by the details contained in complete bid document.**
- 4) **The Director ICAR-NAARM will not be responsible for any delay in enrollment or submission of the offer/uploading the offer on our e-tender portal for any reason whatsoever. - 5) **Price once quoted will be final and no further negotiation/alteration will be made thereafter.**
- 6) **The rates should be quoted as per the BOQ uploaded on the CPP Portal. The bidders are advised to download this BOQ_XXX.xls as it is and quote their offer/rates in the permitted column and upload the same in the Financial Bid. The Bidder shall not tamper/modify downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with ICAR-NAARM.**

- 12) **Proposed Period of Rate Contract:** The contract will be valid for a period one year with effect from the date of award of the contract. The period of contract may be extendable for one year on renewal basis on mutual agreement.
- 13) **Termination of the Rate Contract:** The Rate Contract can be terminated at any time by giving one-month notice on either side.

- 16) Any bid security will not be linked to any pending amount in this organization.
- 17) **Refund of EMD:** The EMD of the unsuccessful bidders will be returned without interest at the earliest after expiry of the final bid validity and latest on or before 30th day after the award of the contract.
- 18) **Security Deposit:** The Successful Bidder has to submit Security Deposit for an amount of **Rs..1,50,000/-** (Rupees One lakh, Fifty thousand only) in the form of DD/BG in favour of "ICAR Unit – NAARM Account" on which no interest will be paid. Security Deposit will be released after completion of all contractual obligations (valid rate contract period for one year) and can be withheld or forfeited in full or in part in case the order is not executed satisfactorily within the stipulated period to the best satisfaction of the organization.

- 21) In respect of perishable stores, the damaged / rejected one should be replaced by the supplier, free of cost at the ultimate destination.
- 22) **Delivery:** Maximum of four weeks from the date of supply order.
- 23) **Payment: 100% of** the contract price on receipt of items by the consignee supported by satisfactory and submission of Performance Security.
- 24) **Dispute resolution:** Decision of Director of the Institute shall be final for any aspect of the contract and binding to all parties. Disputes arising, if any on the contract will be settled at his/her level by mutual consultation and in case of failure of settlement dispute shall be referred to the sole arbitrator to be appointed by the Director, Institute. The decision of the sole Arbitrator so appointed shall be final and binding on the parties. Arbitration proceedings shall be governed by the Arbitration & Constitution Act, 1996. The seat of Arbitration will be Bhubaneswar and language will be English. Laws of India will be applicable.
- 25) The rate should be quoted as per BOQ in online tender.
- 26) The selected firm before supply of items has to show/provide samples of the items to the under signed at ICAR-NAARM, Rajendranagar on demand.
- 27) **Forfeiture of EMD:** EMD will be forfeited if the tenderer withdraws or amend or impairs or derogates from the tender in any respect within the period of validity of their tender.
- 28) **Samples:** The firm should submit the samples of the items wherever applicable along with the tender.
- 29) **Payment :** No advance payment is permissible. Payment would be after satisfactory supply of the entire quantity as per Purchase Order. All payments will be made through RTGS.
- 30) **Change of Defective Goods:** Vendors have to supply the items from the latest stock as per our requirement and if any damage/defective it should be replaced without any additional cost and as per quoted rates in the tender document.
- 31) **Price Escalation:** There should not be any price increase during the Rate Contract.
- 32) **Rates:** Rates should quoted in the Schedule of Requirements enclosed to this notice or on the bidder's letterhead in the same format. The authorized person and is full name should sign the tender and status should be indicated below his signature. Tenders will be considered for which rates have been quoted strictly according to the specification. The rates should be quoted in Indian Rupees only. The rates must be written in figures as well as in words. Any alterations in the rates in tender will not be considered. The rate should include all taxes, if any.
- 33) **Validity of Tender:** Tenders should be valid **till the completion of one year from the date of award of the contract towards supply of items on Annual Rate Contract.** Tenders valid for a shorter period shall be rejected as non-responsive.



- 34) **Penalty:** Penalty as may be decided by the Director, ICAR-NAARM is liable to be levied on the firm/agency who do not supply the items according to required quality / specification and time limit specified in the purchase order. The supply should be as per quality / specifications / time period.
- 35) **Liquidated Damages:** Time is the essence of the order as our requirements are connected with time targeted research programmes. Part supplies are not acceptable under any circumstances. The date of delivery should be strictly adhered. Otherwise, the Director, ICAR-NAARM reserves the right not to accept OR to cancel the order if the delivery schedule is not adhered to in part or full and to claim liquidated damage @0.5% per week or part thereof subject to the maximum of 10% delivered price of the delayed supply of goods by the specified date, will be charged for the number of weeks or part thereof for which the items are supplied after the specified date given in the total value of the supply order.
- 36) **Guarantee:** The tenderer should indicate the guarantee period in the tender. The minimum guarantee period will be one year from the date of acceptance unless an increased period is specifically mentioned in the specification and also the tenderer should specify / indicate the life span of the goods.

Annexure: VI**Instruction for Online Bid Submission**

As per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal ([URL:http://eprocure.gov.in](http://eprocure.gov.in)). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at:

REGISTRATION:

1. Bidder are required to enroll on the e-Procurement module of the Central Public Procurement Portal ([URL:http://eprocure.gov.in/eprocure/app](http://eprocure.gov.in/eprocure/app)) by clicking on the link "Click here to Enroll" on the CPP Portal is free of charge.
2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify /TCS/ nCode / eMudhra etc.), with their profile.
5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
6. Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

PREPARATION OF BIDS

1. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
2. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents – including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
3. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option.
4. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use “My Space” area available to them to upload such documents.
