1. - 5 **The Earnest Money Deposit (EMD) is Rs. 50,000/- (Rupees Fifty Thousands only)** to be submitted in the form of Demand Draft drawn in favor of “ICAR Unit – NAARM A/c”, Hyderabad

from any scheduled Bank and should be sent by speed post as to reach before due date at the above address. The EMD exempted for those registered with Micro, Small & Medium Enterprises (MSME) and National Small Industries Corporation (NSIC). The unsuccessful bidders EMD will be returned soon after the finalization of Tender, whereas the successful bidder EMD will be returned subject to furnishing the required Performance Security. The amount of EMD submitted along with tender document will be forfeited in the event of failure to supply the equipment after issue of supply order. The decision in all these matters shall be final and binding on you. No interest will be paid on Earnest Money/Security Deposit for the period of retention in the NAARM.

- 6 **Performance Security:** The successful bidder must deposit 10% of the work order as Security Deposit / Performance Security within the stipulated time in the form of a fixed deposit / bank guarantee from any scheduled bank drawn in favour of "ICAR-Unit – NAARM Account".
- 7 The duly filled Application form along with the relevant supporting documents and Price bid must be submitted through **online mode only on <http://eprocure.gov.in>**. Bidders would be required to register themselves in the CPP Portal. For submission of bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA).
- 8 All the required documents (self-attested) in support of eligibility criteria are to be uploaded along with the tender documents. All pages of tender documents should be numbered serially. **The bidders are advised to submit duly signed required papers / documents with their bids as per the specifications indicated in online only through Portal: <https://eprocure.gov.in> failing which their bids will be rejected.**
- 9 The successful bidder has to furnish an amount equivalent to ten (10) per cent of the order value as Performance Security Deposit, which will be refunded / returned only after satisfactory completion of the contractual obligations during subscription period of Three Years. The Security Deposit should be in the form of Fixed Deposit Receipt or Bank Guarantee from any Commercial Bank and on which no interest will be paid.
- 10 All communications must be addressed to the above Officer by designation but not by name.
- 11 **Payment:** No advance payment is permissible. Payment will be made only after satisfactory supply & installation of the software in couple of weeks with due certification of the concerned in-charge. Payment will be made.
- 12 **License:** The software license for VMware **Virtualization Software - Academic VMware Horizon 7 Advanced - 10 Pack (Named Users) should be is perpetual and license for support and services will be one year only.**
- 13 **Place of Delivery:** Stores & Purchase Officer, National Academy of Agricultural Research Management, Rajendranagar, Hyderabad – 500 030, Telangana.



- 14 Liquidate Damages:** if you are failed to deliver the software or to perform the services with in the delivery period specified above, a sum equivalent to 0.5% of the contract price per week or part thereof off delay until actual delivery or performance shall be deducted from the bill up to a maximum deduction of 10% of the contract price. Once the maximum is reach ed, we may consider termination of the contract.
- 15 Bank details for e-payment:** The bank details may be furnished along with tender for making e-payment to the successful bidder.
- 16 Period of Validity:** The rates quoted shall be valid for a minimum period of 90 days beyond the date of opening of tenders.
- 17 Rates:** Rates should be quoted in the prescribed Price Schedule in Indian Rupees only.
- 18 Specifications:** Full specifications of the item quoted for should be indicated in the tender along with illustrated pamphlets, drawings etc. wherever available. The supplier has to submit the compliance statement on the technical specifications in the prescribed format enclosed to this schedule.
- 19 Taxes:** Rates should be quoted without GST and with GST in the Price Bid (applicable GST).
- 20 Service Support and Warranty:** Comprehensive warranty and Service from the date of installation and acceptance by the Academy as specified in the Schedule of Requirements. However, the OEM warranty, which exceeds the period specified in the Schedule of Requirements, should be extended accordingly.
- 21 Enquiry's on tender:** Any enquiry's regarding the tenders will not be entertained once the tenders are opened.
- 22 Acceptance of tender:** Director, ICAR-NAARM reserves the right to accept or reject any of the tenders either in part or in full without assigning any reason thereof.
- 23 Quantities:** Director, ICAR-NAARM reserves the right to reduce or increase the quantity at the time of placing the Purchase Order.
- 24** The Technical Bids are to be evaluated technically by the Institute Technical Advisory Committee (TAC). At the second stage Financial Bids will be opened only for the technically qualified tenders for further evaluation before awarding the contract.
- 25 Decision:** The Decision of the Director, NAARM on any dispute in the matter will be final and legally binding.
- 26 Jurisdiction:** All disputes including court proceedings shall be settled within the Hyderabad jurisdiction only.
- 27 Rejection of tenders:** Tenders not complying with the above conditions are liable to be rejected.



IMPORTANT NOTE: The bidder should submit the Technical & Financial bid separately through **online only**, which includes products details in the Technical Documents and Item wise price details in the Financial Bid. The Technical bid must be accompanied with proof of earnest money deposit. In any case, the technical bid without EMD/Demand Draft will not be entertained.

Other conditions:

1. The tenders **without EMD amount will not be considered.**
2. The supply and Installation of **“VMware Virtualization Software - Academic VMware Horizon 7 Advanced - 10 Pack (Named Users)”** as per supply order shall be supplied to ICAR-NAARM campus.
