**NOTICE INVITING TENDER FOR**

**AMC (Non-Comprehensive) OF ACB (AIR CIRCUIT BREAKERS), VCB (VACUUM CIRCUIT BREAKERS) & POWER CONTACTORS AT ICAR-NAARM HYDERABAD**

ICAR-NAARM is a premier publicly funded Training and Research Management Organization under ICAR, DARE, Ministry of Agriculture & Farmers Welfare, and Government of India. The Director, ICAR-NAARM invites Bids from the reputed and Registered Agencies/Contractors who are having relevant experience for **Annual Maintenance Contract (non-comprehensive) of ACB (Air Circuit Breakers), VCB (Vacuum Circuit Breakers) & Power Contactors installed at ICAR-NAARM, Rajendranagar, Hyderabad.** The bidders are requested to submit the Tenders online on CPP Portal.

**Eligibility Conditions:**

1. The firm should be registered/incorporated with state government having its office at Hyderabad/Secunderabad.
2. The firm should have executed at least two works related to Maintenance of ACB (Air Circuit Breakers), VCB (Vacuum Circuit Breakers) & Power Contactors in Government/Public/Private Sector Undertakings of value Rs 1 lakh or above during the last 2 financial year.

The details of number and specifications of items to be kept under annual maintenance along with the Scope of Work are provided in the Schedule – A.

## **GENERAL TERMS AND CONDITIONS:**

1. **Cost of Tender document:** The cost of Tender document is free. The terms and conditions for maintenance of Digital Online Courses and information format can be downloaded from NAARM Website (<http://www.naarm.org.in/>) or the Government of India, Central Public Procurement Portal (<http://eprocure.gov.in/cppp/>). Director, ICAR-NAARM reserves the right to accept or reject any tender(s) or in full without assigning any reason thereof.
2. **Earnest Money Deposit:** An earnest money deposit of (EMD) Rs. 5,000/- (**Rupees Five Thousand** only) must be deposited in the form of Demand Draft in favour of NAARM MAIN ACCOUNT and payable at Hyderabad.

Scanned copy of the EMD is to be uploaded while submitting the Tender online and the hard copy of the same should be submitted to the Stores and Purchase Officer before closing date of the Tender. If NSIC/MSME Certificate etc for exemption is available the submission of EMD is exempted but the certificate is to be uploaded on CPPP.
3. The unsuccessful bidders EMD will be returned soon after the finalization of Tender, whereas the successful bidders **EMD** will be returned subject to furnishing the required **Performance Security/Security Deposit**.
4. All communications must be addressed to the Director, ICAR-NAARM, Rajendranagar, Hyderabad.
5. **Payment:** No advance payments will be done. The payment will be done quarterly (3 months). The vendor has to submit pre-receipted bill in triplicate in the name of Director, ICAR-NAARM, Hyderabad alongwith the joint inspection report for every month of quarter. On certification by end user regarding satisfactory services during the quarter the same will be processed for payment. The quarterly payment amount will be 25% of the annual rates quoted in the tender.
6. **Security Deposit:** The successful bidder has to furnish an amount equivalent to ten **(10) per cent** of the order value as **Performance Security Deposit** which will be refunded / returned only after satisfactory completion of the contractual obligations including warranty. The Security Deposit should be in the form of Demand Draft, Fixed Deposit Receipt or Bank Guarantee from any commercial bank and on which no interest will be paid.
7. **Bank details for e-payment:** The bank details may be furnished along with tender for making e-payment to the successful bidder.
8. **Period of Validity:** The rates quoted shall be valid for a minimum period of **90 days** beyond the date of opening of tenders.
9. **Rates:** Rates should be quoted in the prescribed Price Schedule in Indian Rupees only.
10. **Taxes / Duties:** If taxes, duties, or any other charges over and above the rates quoted are payable by the Academy, actual / percentage of such taxes / duties / charges should be clearly indicated.
11. **Duration:** The awarded work should be for one year from the **date of signing the agreement**. During this period, items as per the SCOPE OF WORK are to be done every month.

12. **Liquidated damage:** In case, the firm fails to maintain components and any such discrepancy leads to a down time a sum equivalent to 0.5% of the contract price per 6 hours shall be deducted from the Bill up to a maximum of 10% of the contract price. Once the maximum is reached, we may consider termination of the contract.
13. **Enquiry's on tender:** Any enquiry's regarding the tenders will not be entertained once the tenders are opened.
14. **Acceptance of tender:** Director, ICAR-NAARM reserves the right to accept or reject any of the tenders either in part or in full without assigning any reason thereof.
15. **Decision:** The Decision of the Director, ICAR-NAARM on any dispute in the matter will be final and legally binding.
16. **Jurisdiction:** All disputes including court proceedings shall be settled within the Hyderabad jurisdiction only.
17. **Rejection of tenders:** Tenders not complying with the above conditions are liable to be rejected.
18. **Evaluation:** Both Technical Bids and Financial Bids are evaluated by the Committees of the institute before awarding the contract.
19. **The tenders without EMD amount or without valid exemption certificate will not be considered.**
20. In the event of the date & time specified for tender receipt being declared as a closed holiday for purchaser's office, the due date for submission of tenders will be the following working day at the specified timings.
21. Director, ICAR-NAARM reserves the right to accept or reject any or all the tenders. Decision of the Director will be final and legally binding. All disputes will be subject to Hyderabad Jurisdiction only.
22. The rates are net and inclusive of all taxes, transport, royalty, octroi etc. and nothing extra will be paid on any account.

**SCOPE OF WORK**

1. The ACB/VCB to be taken for servicing shall be jointly inspected for IR Value, main/arcng contacts condition, missing components if any before servicing ACB/VCB. The AC/VCB shall be racking out from the panel and shifted to convenient place.
2. Removal of ACB/VCB from the cradle and dismantling of components.
3. Cleaning of dust, spider web, foreign particles etc. and electrical contacts.
4. Removal of old grease from various parts of ACB/VCB.
5. Cleaning of all parts with cleaning agent such as CRC2 26.
6. Checking of arcing contact gap, releases and make it correct.
7. Check the tightness of hardware and also presence of missing hardware (to be supplied by customer)
8. Fixing spares which needs replacement.
9. Re grease as recommended in service manual.
10. After cleaning lubricating parts, the ACB will be assembled back and carried out all checks as per checklist. To ensure it freeness and proper operation.
11. Check the ON and OFF operation, tripping operation through various releases, lockable trip push button.
12. Check the IR Values.
13. After completion of all the above works putting breaker back in service position.
14. Set the over load, short circuit, earth fault settings as per customer requirement.

***All the above activities have to be performed by the Contractor every month and the joint inspection report for every month should be submitted alongwith quarterly bill.***
